

Involvement of selected French financial institutions in financing Israeli banks

Introduction

This note provides an overview of investments by selected French financial institutions in a selection of Israeli banks.

The following financial institutions and their subsidiaries were considered:

- AXA
- BPCE Group
- BNP Paribas
- Crédit Agricole
- Société Générale

Investments in the following Israeli banks were researched:

- Bank Hapoalim
- Bank Leumi
- Israel Discount Bank
- Mizrahi Tefahot Bank
- First International Bank

These banks have been identified by various sources as financing activities in the occupied Palestinian territories.¹ No background information on the involvement of these banks in the settlement economy is included in this note.

Information on shares of the Israeli banks owned or managed by one of the selected French financial institutions or their subsidiaries have been researched on fund level, based on the most recent available fund filings. Based on these filings, relevant investments by AXA, BPCE Group and Crédit Agricole have been identified. The overview does not claim comprehensiveness though as complete filings cannot always be accessed.

1.1 AXA

Table 1 shows investments in the selected Israeli banks via funds (co-)managed by subsidiaries of AXA.
